Sub: Outcome of the Extraordinary General Meeting held on March 21, 2024 of M/s PHF Leasing Limited

Pursuant to Regulation 30 Schedule III, Part A, Para A of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations"), it is hereby informed that the members in the Extraordinary General Meeting of M/s PHF Leasing Limited ("the Company") held on March 21, 2024 have approved the following matters:

- 1. The Increase in Authorized Share Capital of the Company from existing Rs. 15,00,00,000/- (Rupees Fifteen Crores Only) divided into 1,50,00,000 (One Crore Fifty Lakhs) Equity Shares of Rs. 10/- (Rupees Ten Only) each to Rs. 40,00,00,000/-(Rupees Forty Crores Only) divided into 4,00,00,000 (Four Crores) Equity Shares of Rs. 10/- (Rupees Ten Only) each and consequential amendment in Clause V of the Memorandum of Association of the Company by substituting in its place, the following: -
 - "V. The Authorised Capital of the Company is Rs. 40,00,00,000/- (Rupees Forty Crores Only) divided into 4,00,00,000 (Four Crores) Equity Shares of Rs. 10/- (Rupees Ten Only) each."
- 2. The preferential issue of upto 1,93,75,240 (One Crore Ninety Three Lakhs Seventy Five Thousand Two Hundred and Forty) Equity Warrants ("Warrants") at a price of Rs. 25/- (Rupees Twenty Five Only) per Warrant, with a right to the warrant holders to apply for and be allotted 1 (One) Equity Share of the face value of Rs. 10/- (Rupees Ten Only) each of the Company ("the Equity Shares") at a premium of Rs. 15/- per share for each Warrant within a period of 18 (Eighteen) months from the date of allotment of the Warrants, aggregating up to Rs. 48,43,81,000/- (Rupees Forty Eight Crores Forty Three Lakhs Eighty One Thousand Only)


